

MAY 2020 AUDITIONS INFORMATIONS – COVID19 SITUATION

DEAR SALTO CANDIDATES AND FRIENDS:

As you certainly know, at this moment it is not possible to predict the duration or the real impact of this global crisis. SALTO is located in Portugal, which is currently making an enormous effort to contain the disease, limiting the movement of people for several weeks now (it seems that we are having some success!!!!). The school is, for now, closed, and we are anxiously awaiting authorization from the authorities to return to our normal work (but we don't know when it will be).

This scenario has consequences for the AUDITIONS for the next school year. Thus, we decided to take the following measures:

- 1- Maintain the 22nd to 24th May dates for the hearing process dates and deadlines are for now the same.
- 2- Authorize ALL candidates to replace face-to-face auditions with VIDEO AUDITIONS.
 - 3- SIMPLIFY the audition process to better suit this new situation.
- 4- Postpone the set of new dates for face-to-face audition to a time when there is more solid information.

WE REFUSE TO BE KNOCKED DOWN BY THIS SITUATION. SALTO WILL CONTINUE TO DO EVERYTHING IN ORDER TO PROMOTE CIRCUS TEACHING AND THE CIRCUS WORLD. WE WILL DO EVERYTHING WHICH IS IN OUR REACH TO START THE NEXT SCHOOL YEAR WITH NORMALITY.
